ARCHWAY STATION CELEBRATES 40 YEARS OF SERVICE

Archway Station is a private non-profit providing psychiatric rehabilitation services in Allegany County. The organization is housed on Queen Street in Cumberland. Archway's assets include 10 residential properties in addition to the Queen Street complex and the Memorial Avenue Wellness and Recovery Center. Archway plans to return one residential operation to the Thomas B. Finan Center in 2020 and liquidate properties located on Fulton Street. Archway is preparing a strategic plan for the future which will include looking more at addiction services for those with persistent mental health disorders. Archway works closely with the Behavioral Health Systems Office in the Health Department and provides services to 250 adults and children within Allegany County.

In the spring of 2020, Archway had two signature events planned that had to be postponed due to the issue of the Coronavirus; including hosting the "Chamber After Hours" event and a 40th anniversary celebration. Both events are only being postponed and will be rescheduled when possible. The first ever annual fundraiser was likewise planned for this year but will now kick-off in 2021.

As for the history of Archway and its start in January of 1979, staff representatives from the Allegany County Mental Health Center and the Thomas B. Finan Center met to discuss Allegany County's need for a hospital to community transitional program for mental health patients transitioning

from psychiatric placements. The meeting evolved into a task force of representatives from the group with a goal of developing a community based psychosocial rehabilitation center. Mr. Grady O'Rear was hired as a consultant by the State Regional Office to aid in the development of the program. The task force decided to follow the guidelines of the internationally known foundation — the Fountain House program of New York City. The initial organization commenced operation in the second half of 1979.

The initial start-up came as a result of loaned staff, supplies and vehicles from the Allegany County Mental Health Center and the Thomas B. Finan Center. The first members came to the program in the summer of 1979 from the Allegany County Day Treatment Program and the Thomas B. Finan Center. For the first few months, the group met at the Mental Health Center and did recreational activities at the Finan Center.

In November of 1979, the group moved into the basement of St. John's Lutheran Church at 406 Arch Street in Cumberland's South End. The Clubhouse members chose the name Archway Station and the development of the private non-profit was begun. A Board of Directors and Articles of Incorporation were put in place on April 4, 1980, which is deemed the birthdate for Archway Station.

The first fiscal year commenced July 1, 1980 (FY '81) and saw a major grant from

the Western Maryland Consortium. The grant was \$41,972 and enabled the agency to hire six staff. The funding from the State Department of Health and Mental Hygiene (DHMH) for the same period was \$20,422. At the end of FY '81 funds were depleted and many agency staff had to leave as no new funds were available.

Since that time the organization has grown to a \$5 million dollar annual budget employing 85 full-time and 40 part-time employees and serving both adults and children. The programs currently are: Children Adolescents and Young Adults often called CAYA serving youth to age 18; Supported Housing where people are supported in their own homes or apartments; Targeted Case Management which serves the homeless population; Residential Rehabilitation services where 30 individuals are living in Archway owned properties; and Developmental Disabilities residential services for 13 individuals. Thanks to a generous grant from the Weinberg Foundation Archway began a Health Home program which is housed at the Wellness and Recovery Center. Archway is pursuing funding for an Oxford Recovery House which will serve to assist those who are in recovery and in need of temporary housing and support while working or going to school.


