Last month I mentioned how quickly this year has gone and now we're in December, the countdown to a new year begins, and the Chamber is preparing for its Annual Meeting and Holiday Reception. I was asked to compile a year in review to share at the Annual Meeting and thought I would incorporate some of that into this piece, as well.

The priorities for the Chamber this year were internally focused with attention given to recruitment and retention, leveraging our technology, engagement, and continuing to navigate under COVID. Some of these had to work in tandem. Our website became a true extension of our work, telling our story, and providing information about membership, programs, and services. We created unique opportunities for engagement when we were still unable to be in person and maintained regular programming with many of our committees using Zoom. One of the most difficult priorities was in-person events and taking a chance on their success. These serve as vital fundraisers for the operation of the Chamber, and we were able to host all four major events and exceed our fundraising goals for the year.

Our **Economic Development Committee** hosted programs, including the State of the County and Frostburg State University's economic development plan. Our **Education Committee** honored the Allegany County Teacher of the Year, awarded the Outstanding Business Students, and graduated the **Leadership Allegany! Rising Class** of 2021, which was fully virtual, while also starting the Class of 2022 in person. The **Legislative**

Committee worked through the 2021 session, reviewing nearly 100 bills and providing written and oral testimony for association health plans, and the Task Force on the Economic Future of Western Maryland. **Leadership Allegany!** faced

many roadblocks, paused, and following a meaningful planning session in May, was able to reengage the class and give them the full experience of in-person topic days. The **Marketing and Membership Committees** were both tasked with a full workload as most of our priorities for the year were rooted with them.

It makes me rather uncomfortable to seem boastful, but I feel for the sake of sharing accomplishments, it's necessary in order for me to convey where we stand. Early in the year, I presented the Board with specific goals I had for the Chamber, and a list compiled from our planning session. By the fall of this year, we had either completed, or started the process of every single item on that list. That was made possible by a dedicated and responsive Board of Directors, and the volunteers on our committees. We updated our equity and inclusion statement but outlined very specific objectives and goals we intend to pursue, a dynamic team of female leaders has begun planning for an International Women's Day event, and our committees are talking about collaboration projects and programs. There is still heavy lifting to be done and there is excitement and engagement at every turn.

Thank you for a great first year as your Chamber executive! I look forward to all that is in store for 2022 and hope that if you have some time to give, you'll consider joining a committee...*or two!*

Celebrates 115th Birthday

The Allegany County Chamber of Commerce proudly celebrated our 115th birthday in April. Throughout 2021, each month, we provided our members with interesting tidbits of Chamber history. Last month's newsletter centered on the Chamber's passion and commitment to education and the possibility of a Vocational-Technical training school in Allegany County. This month's feature provides an overview of how that training school became a reality.

As a refresher: At the April 1966 Chamber of Commerce meeting it was announced that the "Board of Education would like the Chamber to prepare a study which will show the extent of vocational technical training needed in our school system and insofar as possible the type of training it should be and the circumstances under which it should be given; that is whether or not it should be developed in the high schools or under a separate facility."

The study continued for several months and in October of 1966 the in-depth study was finalized and presented to the Chamber Board of Directors. Highlights from that study stated "The Board of Education having been prevailed upon by many people to consider the need for expanding the program of Vocational-Technical training asked the Chamber of Commerce to conduct a study in depth of those requirements. The problem of continually adjusting the curriculum of our schools to fit the needs of the people of the community is of utmost importance and it has been recognized that these needs are in all age and economic groups of the community. The Chamber of Commerce has conducted a survey of these needs and the results of this survey have been analyzed by a committee of the Chamber, supplemented by interested members of labor and other groups. It shows that the future needs of employees will be more in the skilled and semi-skilled classification and that there will be job openings for machinists, mechanics, electricians, draftsmen, brick-layers, machine operators, machine repairmen, electronic technicians, tool and die makers, laboratory technicians, all office skills, welding, sheet metal, carpenters, plumbers, millwrights, air conditioning, butchering and food preparation, nurses' aides, pre-nurse training, medical laboratory technicians, dental technicians, practical nurses, etc. Every regional and national poll has emphasized these same findings as a national trend. There are at least two methods by which industry can be supplied the skilled help which it needs. One is by conscripting graduates of vocational training programs, the other is by training programs within the industry. Of the two, the first seems preferable. According to a Wall Street Journal article 'many companies, their resources already strained by near-capacity production, aren't much inclined to undertake the costly task of increasing training programs at the same time. Training costs money. If you can hire a fully skilled man, the amount you have to spend to teach him your way of operating is minuscule in comparison to what it would cost to bring a man through an apprentice program'. Generally, employers say, it costs between \$1,000 and \$5,000 or more to train one apprentice. The committee considered the stigma in certain segments of our population regarding vocational schools as merely dumping places for the low intellectual. It is believed that the Vocational-Technical school should be closely integrated with our community college. Perhaps, certain skills could be carried over to the post high school level and a degree awarded. Certainly, if the two schools were physically close to one another, the sharing of certain expensive equipment and facilities could be accomplished. It would also be advisable to call the school a Technical Institute

rather than a Vocational-Technical School. The committee gave a great deal of consideration to the necessity of training our young people to obtain work elsewhere if they choose to move or when jobs are not available in this area. Regardless of where they choose to spend their adult lives, we owe them a utilitarian education. The committee feels also that the Vocational School should be considered as a year-round training and retraining facility in order to get the greatest use out of it. We, therefore, recommend taking the necessary steps to provide a Technical Institute on the high school, college and adult levels. It should be closely integrated with the community college and it should provide as many courses as is feasible and which will allow for future expansion. The facility should make available those skills required by our local industries for their growth and also for their skills which might be required by new and future employers. In this way, the growth of the individual and the community will be enriched to its fullest potential. Because we believe our county has lagged behind in providing these facilities and because there are state and federal funds available now, we ask the School Board and County Commissioners to make all possible speed in considering and facilitating this project."

At the October 1966 board meeting it was noted the study had been presented to the Board of Education and they formed a committee to determine what size it should be and what subjects should be taught at the outset. Mr. Robert Peterson, Chamber Manager, and Dr. Jack Arch, Chamber board member were appointed as members of that committee. It was noted in the September 1967 minutes that "Dr. Wayne Hill, Superintendent of Schools, had requested that the Chamber reactivate our committee on Vocational Technical Training to further assist the board in selecting proper courses, to assist them in selection of curriculum and also to assist in selection of equipment."

Dr. Wayne Hill attended the May 1969 meeting of the Chamber Board of Directors to provide an update on the new vocational technical school. He stated the school is in the process of being built at a cost of \$3,000,000.00 of which \$70,000.00 is local money. He thanked the Chamber for their considerable time investment in the project.

The Chamber's commitment to education continues today with a wide array of programs and events. Throughout the year the Chamber honors students with our Outstanding Business Student Awards held in conjunction with the Rotary Club of Cumberland, annually honors the Teacher of the Year with a presentation, assists with the WCBC/FSU Scholarship Salute and Focus on the Future. The Education Committee instituted a new program in 2017 – **Leadership Allegany! Rising** which has graduated 89 students from local public and private high schools. In September the Chamber kicked off the program with an orientation. This year we have 21 students involved in the program dedicated to providing positive change by creating a network of future leaders committed to impacting their community. The Allegany County Chamber of Commerce believes today, more than ever, that our future is tied to strong leadership. The more informed and involved our youth become the stronger the community.

We hope you have enjoyed learning more about the history of the Allegany County Chamber of Commerce and we look forward to celebrating for many years to come.
