### Executive Director

*A Chamber of Commerce holds an important place in the foundation of the community. It is a network of its own membership – businesses, organizations, individuals – that collectively make a profound impact.* When I shared this in the January 2021 *Cumberland Times-News*, it was essentially a definition, but as I begin year two as your Executive Director, it has certainly come a long way in helping me define not only what we do, but why we do it.

The 2022 Legislative Session began on January 12 which means the **Legislative Committee** began its weekly meetings that same day. **Jeremy Irons** remains as Chair of this committee with **Cliff Wendricks** as Co-Chair. We are starting this session with a similar protocol as we experienced last year with testimony on Zoom. To testify online in support or in opposition of bills that will have significant impact on our community is quite different than doing so on the floor of the House or Senate. If Annapolis moves to reopen after February 11, it has been said that the Zoom option will remain. There will likely be a handful of bills that our Delegation will ask us to speak to, but none with the gravity of the requests from the Task Force on the Economic Future of Western Maryland, specifically when we ask for support of economic development funding that will total \$100 million over five years. When that bill is dropped, we will request that our community stand together to ensure our voices are heard regarding the impact those dollars would make. Everyone can contribute to that by checking our website ([alleganycountychamber.com](http://alleganycountychamber.com)) for updates, and details to contact the committees. New for this year is a weekly update to our membership that highlights some of the bills we are

watching. A regularly updated list of those bills, along with the Chamber's position can also be found on our website. I hope you are finding these new additions to our communication helpful.

The Chamber welcomed **Andrea Kraft** as our new **Administrative Assistant** in mid-December. Is there ever a *good time* to bring on a new staff person? If there

is, we may have found it – at least for us. She is getting the full Chamber experience right from the start of the year. If you call, Andrea will likely be who answers so please welcome her! We also have a few changes on our committees, and I look forward to working with **Seth Sgaggero** as the new Chair of our **Membership Committee**. Seth also Chairs the committee for the Local Business Showcase, and we are pleased to add **Kristin Ingram, AES Warrior Run**, as his Co-Chair. In addition, **Adam Strott, Allegany County Economic Development** has been named Vice Chair of the **Economic Development Committee**, alongside **Kim Leonard, Chair**.

Despite snow on the ground and likely more to come, we are full steam ahead on planning for the **6<sup>th</sup> Annual Golf Outing** taking place on **May 6** at the *Cumberland Country Club*. Past golfers can expect information soon and we will continue to provide details to help our members gather teams. 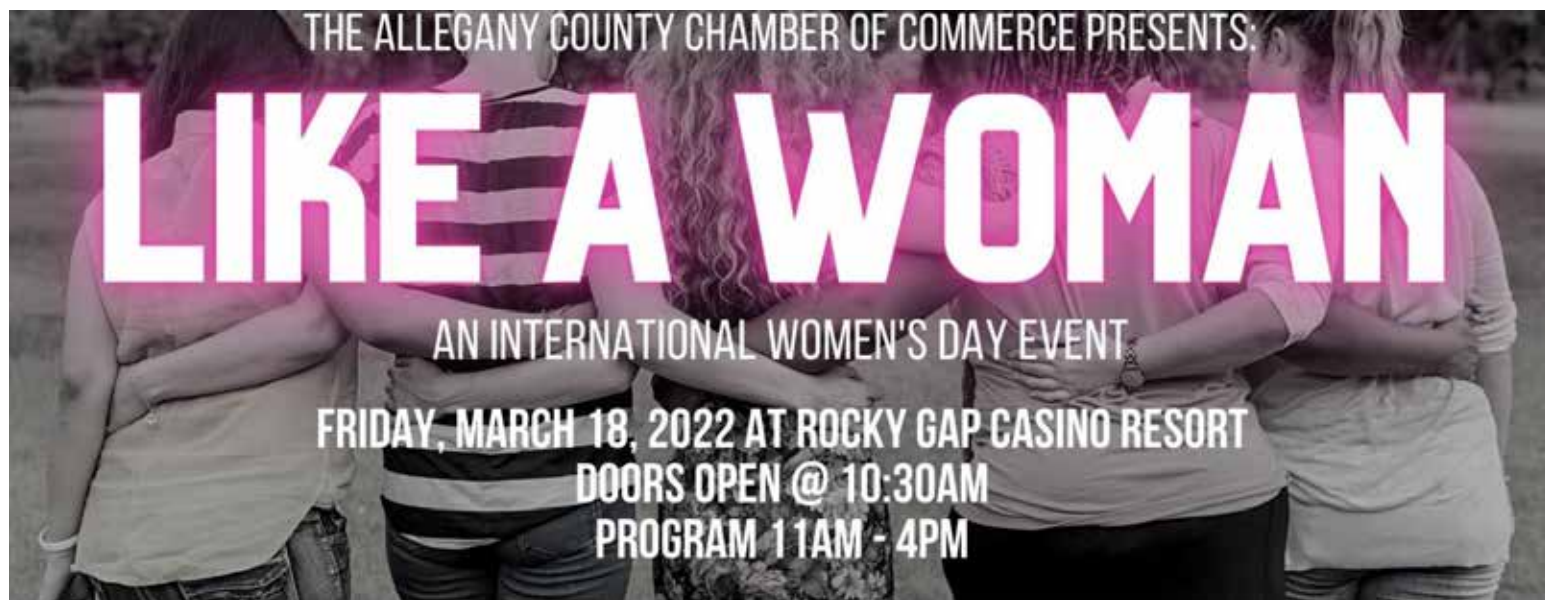

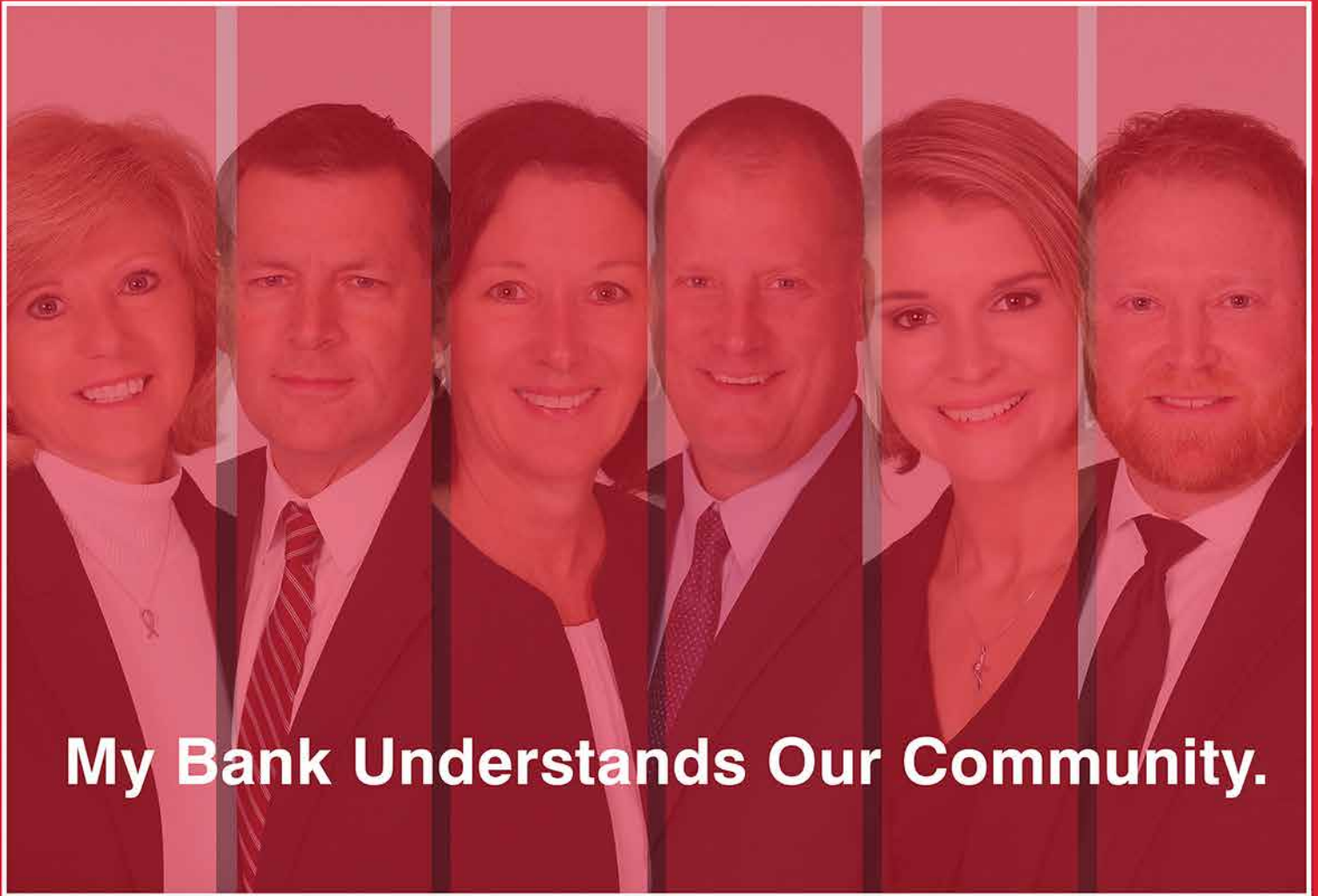
