Our **Chamber After Hours** was held at **Horizon Goodwill** in Frostburg where we are starting to see an increase in attendance, which makes for a great networking event. Next up is **First United Bank** at Centre City in Cumberland on May 18, 5:30-7:30.

Our **Economic Development Committee** took things on the road in April and toured Western Maryland Works in LaVale. The makerspace and training center is a superb facility, both for young people looking to establish themselves in a trade, and for

individuals who want to explore new opportunities as entrepreneurs or a try a new career. If you are someone who would love to experiment with a new hobby, you definitely need to stay tuned to how they will make the makerspace portion of the facility available to the public.

The **2022 Legislative Session** wrapped up on Monday, April 11 with the Maryland Makerspace Initiative Program passing, which will provide additional funds to makerspace programs across the state. Additionally, the *Western Maryland Economic Future Investment Board* and Senator George C. Edwards Fund was established to push millions of dollars in economic investment into the three most-western counties of the state. With the session behind us, the **Legislative Committee** will now begin focusing on candidate forums, which will take place in June to accommodate the later primary elections. These will be both recorded and open to the public and we will make official announcements about this in the coming weeks. We will host a candidate forum for the **City of Frostburg** on Monday, May 9 at 7pm at the Frostburg Municipal Building. This, too, will be in person and on social media. If you wish to submit questions for this forum, please email me by Wednesday, May 4. Coming up on Friday, May 13 is our **Legislative Wrap-Up Luncheon**; the public is welcome to attend and can call 301-722-2820 for more information.

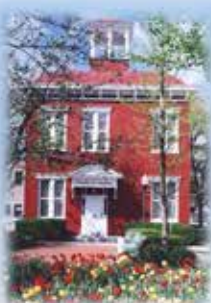
Leadership *Allegany!* Alumni Committee Update

The recent graduates of the **Leadership *Allegany!*** Class of 2021-2022 join the rank of almost 560 individuals who have graduated from the leadership program. To allow graduates an opportunity to continue networking with fellow classmates and interact with other alumni graduates the Alumni Committee was created. On a monthly basis Alumni Committee members meet to develop social, networking and educational programs.

To assist future class members the **Leadership *Allegany!*** Scholarship Fund was created to make the program available to individuals whose financial resources may prohibit or restrict their involvement. Small business owners, non-profit agencies, and individuals are the primary target group for the scholarship fund, but funds are available to everyone. To date, 85 individuals have accessed over \$33,000 from the scholarship fund from the first Class of 1998 through the current Class of 2021-2022. Sixteen percent of the **Leadership *Allegany!*** alumni have been given an otherwise unavailable opportunity to learn about our region, develop their leadership skills, and make a positive impact in our county and communities through the Scholarship Fund. The scholarship fund covers up to 50% of the tuition. We hope you will consider contributing to the scholarship fund as we continue to provide educational and leadership opportunities to all members of our region.

We extend special thanks to members of the Alumni Committee for their contributions, time, and energy in keeping the **Leadership *Allegany!*** experience alive and for building opportunities for other leaders.
