Ribbon Cutting Ceremony

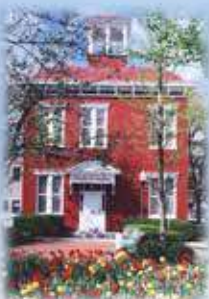
