### Executive Director

We have so much to look forward to in the coming weeks and months, including brighter, longer days, warmer weather, and the end of the 445<sup>th</sup> session of the General Assembly. It has been a tough session for businesses, which are now facing an earlier increase in minimum wage, staring down contributions to paid family and medical leave, and the overall cost of business going up as we all try to compensate. The Chamber remains committed to providing information and resources to its members as they become available.

The Allegany County Chamber of Commerce, along with the Chambers in Garrett and Washington Counties, played a considerable role in the Taskforce on the Economic Future of Western Maryland in 2020 and 2021. That work transitioned into representation on the Board overseeing the Senator George C. Edwards Fund. Throughout 2022, our work was focused on forming policies and procedures to open funding opportunities for a first round of \$20 million in investments targeted at job creation and retention, increasing wages, creating and retaining businesses, and generating new tax revenue. We learned in January and February that legislation was being developed that would change the make-up of the Board. While the Chamber did not testify in opposition, we did choose to submit a letter of information to the Western Maryland Delegation, which noted our key areas of concern. After a meeting with the George Board and the Delegation, amendments were made to address some representation. While Chambers of Commerce exist to serve their members, it has always been my goal to ensure that in situations where an inclusive and more unified voice is needed, I consider it as work for the good of all. In this instance, it has been my pleasure to represent the full business community. Unfortunately, as

this local interest bill moves through its hearings and will likely pass, my time, and some others, will end on that Board. Although much of these discussions have remained with the Chamber's Board of Directors, I feel it is important that the full membership is aware of how my time is spent pertaining to broader Chamber issues.

We announced last month that **Like a Woman** will return with a *Breakfast Edition* and we are thrilled to bring the premiere program back again this year to allow participants to focus on their current and desired strengths, opportunities, aspirations and to discover ways to achieve results. We have identified a great slate of featured speakers who will focus their comments on these very specific areas. Details and a link for reservations can be found on our event web page.
