### Executive Director

In just a few days we will host our **7<sup>th</sup> Annual Golf Tournament** and once again we have a full field. Thank you to all of our golfers who will be joining us Friday, May 5. Will Rocky Gap Casino Resort defend their wins from the past two years or will the Bell Tower Cup go to another winner? This event has grown to be a great success for the Chamber thanks to our golfers and our sponsors, including **Gold: AES Warrior Run, Chessie Federal Credit Union, Cintas, M&T Bank, Rocky Gap Casino Resort, Verizon, and Silver: Timbrook Automotive.**

**Lucky Ladies Night Out** will be happening June 9 and the committee has been busy collecting basket raffles and working on all of the details that make this a great evening. Thank you to our sponsors **The Kristi Agency – Allstate, Bella, LLC, and WEPCO Federal Credit Union.**

The month of April was packed with programs, including the **Legislative Wrap-Up**, a workshop on Maryland Saves, and **Like a Woman: Breakfast Edition**. Maryland Saves is an important program to pay attention to if you offer payroll through an automatic deposit system. We will be sending an information sheet about this later in the week and I encourage you to check out the basic outline and consider next steps. We went into the Legislative Wrap-Up knowing that our delegation had a tough session debating a minimum wage increase, exhausted their arguments on cannabis regulations, and had to become familiar with a new administration that is one of the most progressive that our state has seen in nearly a decade. It was a long session (*yes, we say that every year*), but it was a sense of going in knowing that our asks for amendments would likely not be

avored. Although there were some wins within the big bills that passed, they were minimal, and the impacts will be felt as early as the fall of this year. What we currently know about family medical leave (FAMLI) is that the cap was set at 1.2% with a 50/50 split, but the implementation (October 2023) will begin at .8 -.9% of gross

wages, and the first benefits through this program can be taken as early as January 2026. We will continue to provide updates as they become available, and we will send additional details soon. It is important that you share information about this with your employees as early as possible.

The Chamber has a number of committees which help define some of the work we do. Our Education Committee, throughout April, finalized selections for the FSU/WCBC Student Salute scholarship awards, presented our Teacher of the Year award to Dr. Joseph Thompson at Fort Hill High School, wrapped up **Leadership Allegany! Rising** with a Class of 2023 graduation, has compiled its list of Outstanding Business Students for the year, and reviewed our scope of work for the remainder of the year. Our Economic Development Committee has been considering its function within the Chamber and we recently convened economic development stakeholders from the cities of Cumberland and Frostburg, the county, and downtown Cumberland to discuss what we might accomplish together that is necessary to the upward trajectory of our community.

Your support of the Chamber allows us to continue this type of work. We are making connections in the community that are important to improving our future, and although we share a great deal of information about events, sponsorships, and advertising, it is through these mechanisms that we are successful. Much of what we do shines a light on your business, and we thank you for seeing the value in our efforts.

## ALLEGANY COUNTY CHAMBER OF COMMERCE RECOGNITION RECEPTION

The Allegany County Chamber of Commerce is seeking nominations for its 2023 Recognition Awards. The award winners are honored at the Chamber's Reception in November 2023. Since 1988, the event has been the Chamber's premier annual opportunity to recognize Allegany County's most notable successes among its membership.

### CRITERIA FOR HONOREES

The Chamber's awards are given annually at the Recognition Reception. The awardees are limited exclusively to Chamber members who are recognized by their peers as making exemplary contributions to the community by:

1. Contributing to the betterment of the region through community service, leadership roles, and achievements that benefit the people and the progress of our county.
2. Demonstrating an exemplary model in professional and personal practice. Awardees provide a role model for other business professionals and community leaders; hold a greater vision for self and for company ethic that models progress; and raise the standard for professionals locally.

Criteria for the **Business of the Year** are based on the following:

For the business best demonstrating positive economic impact in our community while including significant contributions to the community's growth and well-being. This business would demonstrate an exceptional level of representing their industry and the local business community as a whole. Benchmarks may be exemplary staying power, sales growth, employee growth, production expansion, significant improvement in financial position, etc.

Criteria for the **Entrepreneurial Spirit Award** are based on the following:

For the individual, founder, or team who has demonstrated the best of community-wide benefits of the entrepreneurial spirit. Benchmarks may be a significant product, service or technology innovation, successfully taking a division in a totally new direction, starting a new product/service line, innovative ways to overcome significant challenges, etc.

Criteria for the **Community Service Award** are based on the following:

For the individual or organization best demonstrating Chamber members' involvement in community service. Benchmarks may be demonstrations of regularly going above and beyond their core mission, in order to serve our broader community.

**New for 2023, the Chamber wishes to honor one of its nonprofit members.**

Criteria for the **Nonprofit of the Year Award** are based on the following:

For the organization that has demonstrated community service, as indicated in their defined mission and vision. Benchmarks may include meeting or exceeding fundraising goals to exceed their intended investment in the community, or creating and successfully implementing a program or service that addresses a community need.



## NOMINATIONS FOR AWARDS

Any designated representative of a Chamber member may nominate another Chamber member [self-nominations are acceptable].

The basic **Nomination Package** must include:

- Single cover page listing:
  - Full name, title, business & home address, all contact phones/faxes/emails of **Nominee**
  - **Award** for which nomination is being made
  - One paragraph summary of nominee's business or organization, date of establishment, scope
  - Full name, title, business address, contact info of **Nominator**
- **Letter of Nomination** (1 to 3 pages) which specifically details those outstanding actions and characteristics which elevate this person and/or organization above others. Nominators should keep in mind the large number of very active local businesses and individuals and highlight those attributes and performance that merit the award.
- **Signed Release** giving the Chamber permission to, at the Chamber's discretion, promote the nominee in media, publications, etc.

The **Nomination Package** may also include **Appendix/Supplemental Information** such as new articles, photographs, magazine articles, etc.

All complete **Nomination Packages** must be postmarked or received by the Chamber office by 4:00pm **Friday, June 16, 2023**. Incomplete packages or packages received after the deadline will not be considered.

The award winners will be chosen by a committee consisting of the Allegany County Chamber of Commerce 1<sup>st</sup> Vice Chair, two Past Chairpersons, a selection from the general membership, and the honorees from the previous years' awards.

**All business award winners and (up to three) nonprofit finalists will be notified on or before Friday, July 28, 2023.** The nonprofit award will be announced the evening of the reception.

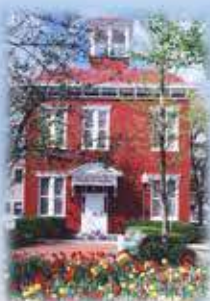
