Annual Membership Meeting Write-in Candidates

- Attend Chamber events, including *After Hours*, Golf Tournament, Local Business Showcase, Lucky Ladies Night Out, Holiday Reception, Crab Feast, Ribbon Cuttings and Recognition Reception
- Assist with Chamber events and fundraisers
