### ALLEGANY COUNTY, MARYLAND

Located at the crossroads of East and West, Allegany County is situated in the heart of Western Maryland and is equidistant from Baltimore, Washington, D.C. and Pittsburgh. With an economy that is just as highly interconnected with its neighbors in Pennsylvania and West Virginia as it is with the rest of Maryland, Allegany County leads the region in healthcare, education and advanced manufacturing. Its historic downtowns and abundance of outdoor recreation draws visitors worldwide, and innovative entrepreneurs



are empowered through local programs that help to redevelop existing legacy structures into vibrant new businesses and housing options. With an emphasis on quality of life and livability, Allegany County continues to distinguish itself by embracing its past and looking towards the future.

Allegany County is home to Frostburg State University and the University of Maryland Center for Environmental Science, both University System of Maryland institutions, while Allegany College of Maryland offers degree and non-degree training programs and

operates The Western Maryland Works makerspace, training the next generation of advanced manufacturing technicians. High-tech start-ups utilize the facility to prototype their next product line, and the County is in the process of developing a dedicated tech incubator, located on Main Street in Frostburg.

The county's private sector industries generate \$2.1 billion in economic output.

#### **BUSINESS AND INDUSTRIAL PROPERTY<sup>6</sup>**

Allegany County currently has eight modern industrial parks located in and around the Cumberland and Frostburg areas, as well as a wide variety of commercial buildings and offices.

The Barton Business Park is home to build-ready pad sites in an Enterprise Zone, conveniently located just a few miles off I-68 on U.S. Route 220.

The Frostburg Innovation Park is owned and managed by Frostburg State University and has acreage available for businesses ready to expand, as well as Class-A office space at the Allegany Business Center, all adjacent to the University. Allegany County is also building out a tech incubator, and will have space available for tenants in the software development industry.

Mass Transit: Allegany Transit bus service

Rail: CSX Transportation; reciprocal switching agreement in effect with Norfolk Southern Railway; passenger service via Amtrak

Truck: 130 local and long-distance trucking establishments are located in Western Maryland

Water: Port of Baltimore, 50' channel, 130 miles east of Cumberland; a leading U.S. automobile and break-bulk port; seven public terminals including the state-of-the-art Intermodal Container Transfer Facility

Air: Cumberland Regional Airport features two paved, lighted runways (3300' and 5000') with an instrument landing system

#### RECREATION AND CULTURE

Parks: Rocky Gap State Park, Dan's Mountain State Park, Wills Mountain State Park, New Germany State Park, Green Ridge State Forest, Constitution Park (within the city of Cumberland) and Parris N. Glendening Recreation Complex (within the city of Frostburg).

**Downhill Skiing:** Wisp, Seven Springs, Hidden Valley, Whitetail and Blue Knob are located within 50 miles of Cumberland.

Cross Country Skiing: Trails available in state parks.

Outdoor Recreation: 76 miles of bike trails along the C&O Canal and the Great Allegheny Passage; numerous trout streams, and fishing on Lake Habeeb and the Potomac River.

Breweries, Distilleries and Wineries: 1812 Brewery, Charis Winery & Distillery, Dig Deep Brewing Co., Locust Post Brewery, Route 40 Brewing and Distillery and The Toasted Goat Winery.

Cultural: Allegany Arts Council, Frostburg State University Cultural Events Series, Allegany County Historical Society, Allegany County Museum, Cumberland Theatre, Heritage Days Festival, Summer in the City concert series and DelFest, a multiday bluegrass and Americana music festival at Allegany Fairgrounds.

Arts & Entertainment Districts: Cumberland, Frostburg. Historical: C&O Canal National Historic Park, Toll House, Narrows, Gordon-Roberts House, George Washington's Headquarters, Fort Cumberland, Thrasher Carriage Museum.

Shopping and Gaming: Downtown Cumberland and Main Street Frostburg offer a variety of local restaurants, bars and boutique shopping and Rocky Gap Casino Resort offers slot machines and table games.
